Alliance of Former Chief Justices – Open Letter

December 15, 2025

Accumulating the immense powers of government in the same hands “may justly be pronounced the very definition of tyranny,” wrote Founding Father and later President James Madison. So, in America, those powers are divided by the U.S. Constitution and every state constitution among three branches—executive, legislative, and judicial.

All state judges take an oath to uphold the U.S. Constitution and their state constitution, which includes respecting the constitutional division of power among the branches. Members of the executive and legislative branches seek election by promising to pursue policies favored by their various constituents. Judges, however, have only one constituent: the rule of law. By their oath, judges promise equal justice to all without regard to means, position, background, or social standing—and certainly without regard to politics. This is true whatever the method their state uses to select and retain judges in office.

Judges cannot take sides and keep their oath to provide equal justice to all. Some people, particularly those with strong policy views, chafe under this system. They may attack judges in the hope of influencing their rulings or convincing the public that the judiciary is just another political branch. While commenting on whether particular cases were rightly or wrongly decided is a basic part of public discourse, assertions that judges are mere politicians in robes are different. Such attacks undermine the integrity of the rule of law and threaten the promise of equal justice. These attacks upset the careful balance that Madison and the other Founders crafted to limit government overreach and protect the freedoms of all.

Former chief justices of state supreme courts understand this. All have led their states judicial branch of government, working to see that our laws are fairly administered in tens of millions of cases each year—civil, criminal, family, juvenile, housing, and others. They can help the public better understand how an independent judiciary that ensures the rule of law is vital to every American. As President Dwight Eisenhower recognized in creating Law Day, “If civilization is to survive, it must choose the rule of law.”

On this Bill of Rights Day—December 15—we publicly and proudly pledge our continued dedication to protecting both the blessings of liberty and the rule of law by creating the Alliance of Former Chief Justices. We and others who join this mission will work with judges, lawyers, legislators, other public officials, and all people for the strong and independent judiciary our Founders envisioned.
